




### description/ordering information

These hex inverters are designed for 2-V to 5.5-V  $V_{CC}$  operation. The 'LV04A devices contain six independent inverters. These devices perform the Boolean function  $Y = \overline{A}$ .

These devices are fully specified for partial-power-down applications using I<sub>off</sub>. The I<sub>off</sub> circuitry disables the outputs, preventing damaging current backflow through the devices when they are powered down.



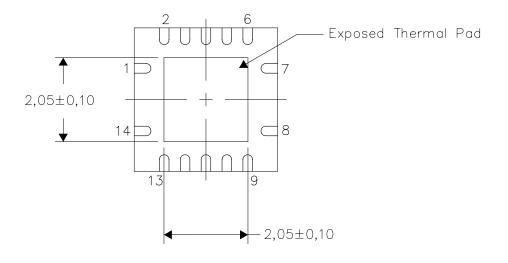

Exposed Thermal Pad Dimensions

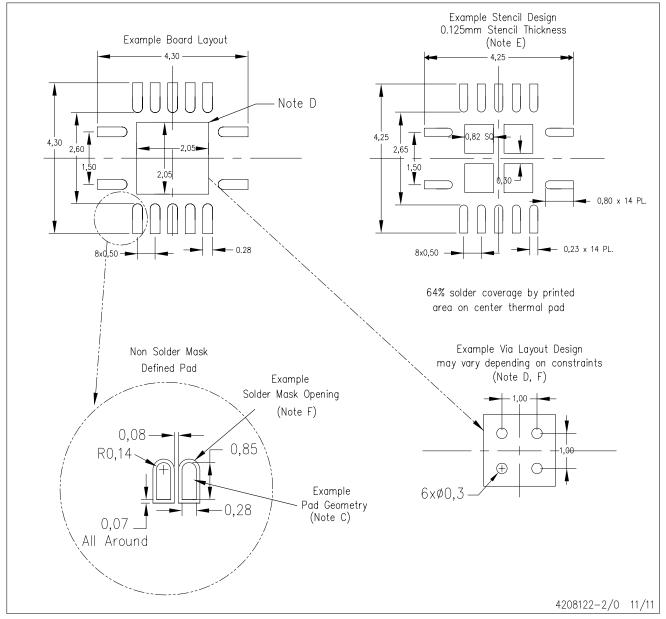
