
TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted





Transfer Characteristics







Normalized Thermal Transient Impedance, Junction-to-Case

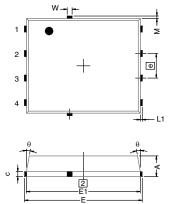
