TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






Transfer Characteristics



Capacitance






TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted





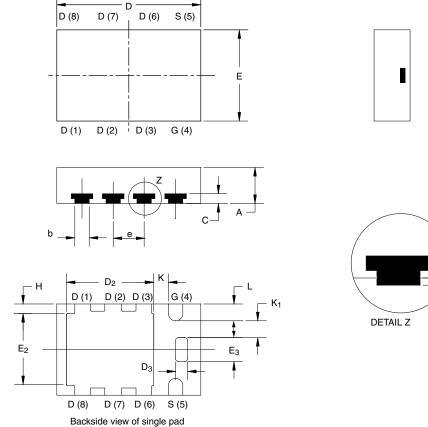

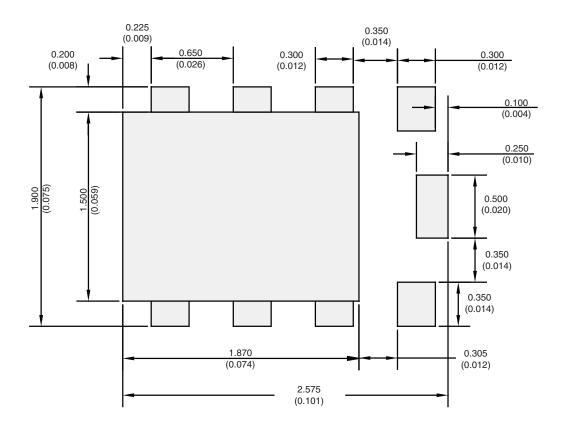
