

F Typical Insertion Loss Characteristics:

Differential Mode

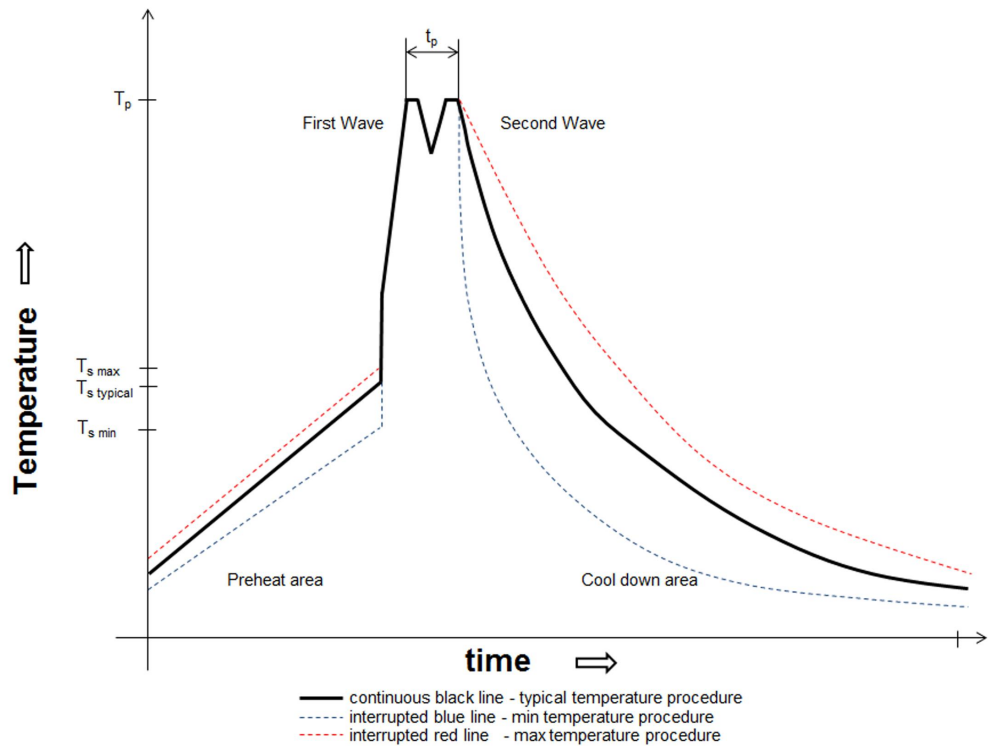




