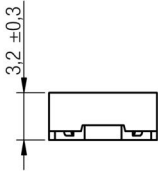

C Schematic:

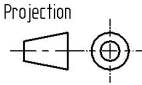

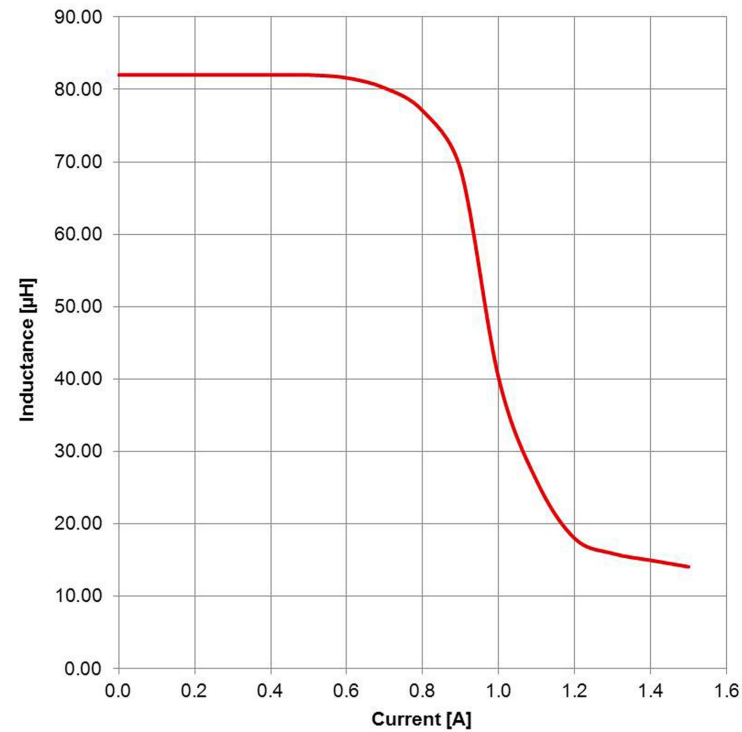


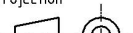
