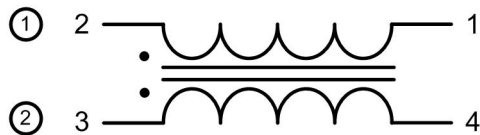



F Typical Insertion Loss Characteristics:



Common Mode

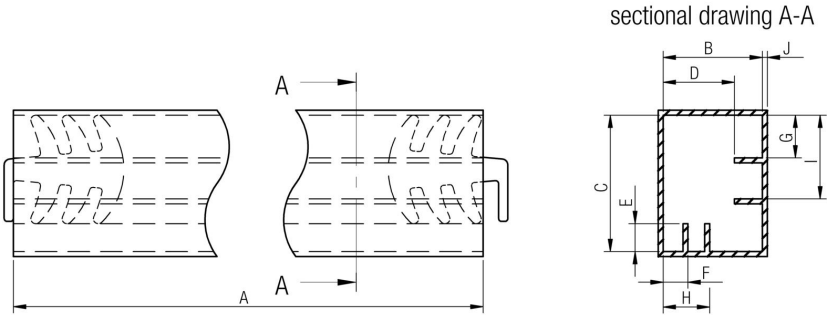


Differential Mode

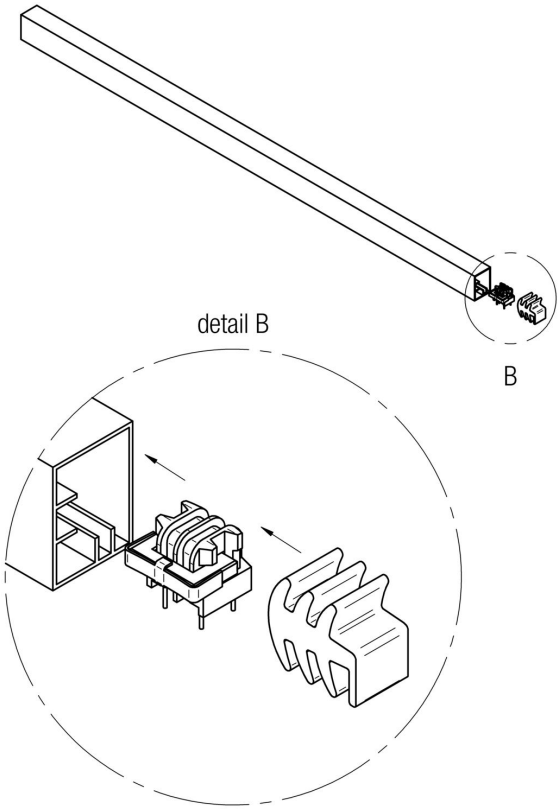




