


Accordingly to this the product is exposed to the pressure of the potting material with the effect that the core, wire and termination is possibly damaged by this pressure and so the electrical as well as the mechanical characteristics are endanger to be affected. After the potting material is cured, the core, wire and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

The responsibility for the applicability of customer specific products and use in a particular customer design is always within the authority of the customer. All technical specifications for standard products do also apply for customer specific products.

Cleaning agents that are used to clean application might damage or change the characteristics of the component, body, pins or termination.

Direct mechanical impact to the product shall be prevented as the ferrite material of the core could flake or in the worst case it could break.

- •The soldering profile has to be complied with according to the technical wave soldering specification, otherwise no warranty will be sustained.
- •Reflow soldering is only allowed after evaluation and approval.
- •All products shall be used before the end of the period of 12 months based on the product date-code, if not a 100% solderability can't be warranted.
- •Violation of the technical product specifications such as exceeding the nominal rated current will result in the loss of warranty.
- •Due to heavy weight of the component, strong forces and high accelerations might have the effect to damage the electrical connection or to harm the circuit board and will result in the loss of warranty.
