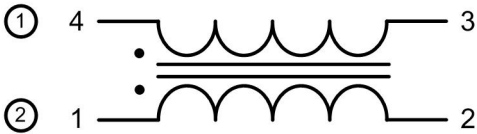



F Typical Insertion Loss Characteristics:



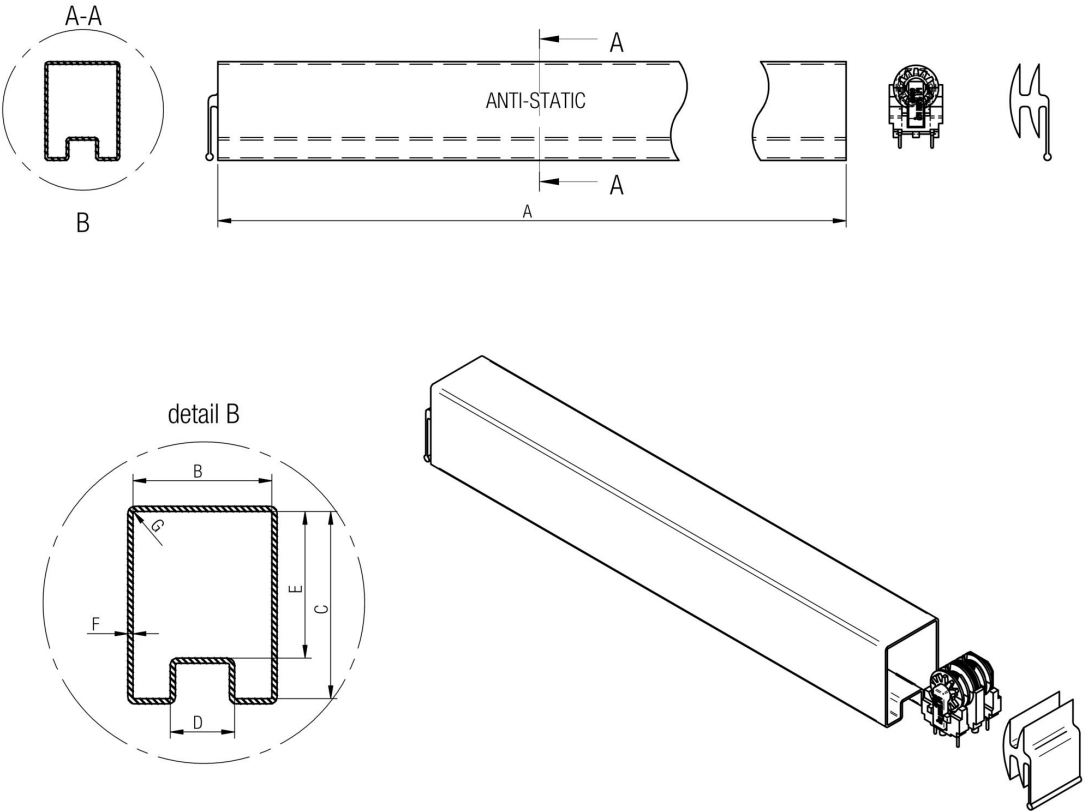

H4: Classification Wave Soldering Profile:






