






Fig. 5.3.1 Switching Time Test Circuit




Fig. 6.1 Marking




Fig. 6.2 Pin Condition(Top View)




Fig. 7.1 $I_D - V_{DS}$




Fig. 7.3 R_{DS(ON)} - V_{GS}




Fig. 7.5 R_{DS(ON)} - T_a




Fig. 7.2 I_D - V_{GS}




Fig. 7.4 R_{DS(ON)} - I_D




Fig. 7.6 V_{th} - T_a




Fig. 7.7 |Y_{fs}| - I_D




Fig. 7.9 C - V_{DS}




Fig. 7.11 Dynamic Input Characteristics




Fig. 7.8 IDR - VDS




Fig. 7.10 t-I_D




Fig. 7.12 r_{th} - t_w





Fig. 7.13 P_D - T_a
