#### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






T<sub>J</sub> - Junction Temperature (°C)





Normalized Thermal Transient Impedance, Junction-to-Case (Drain Top)

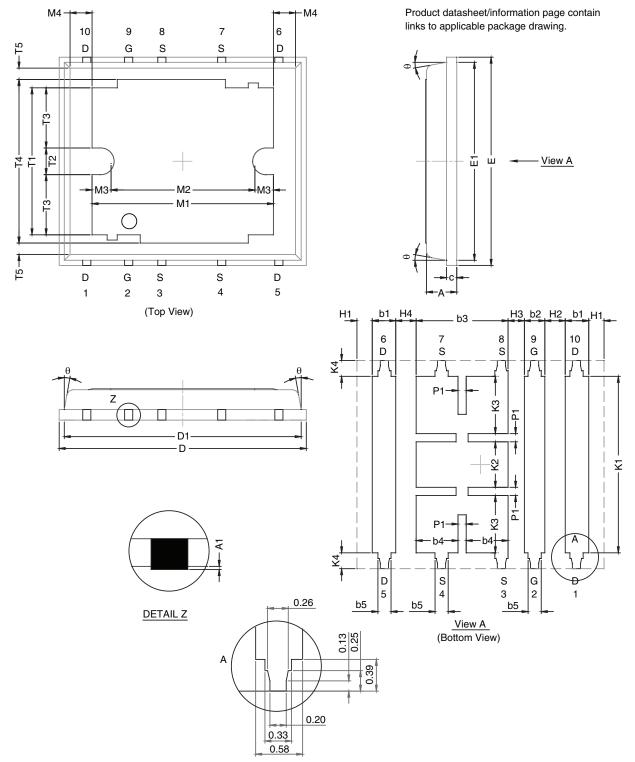

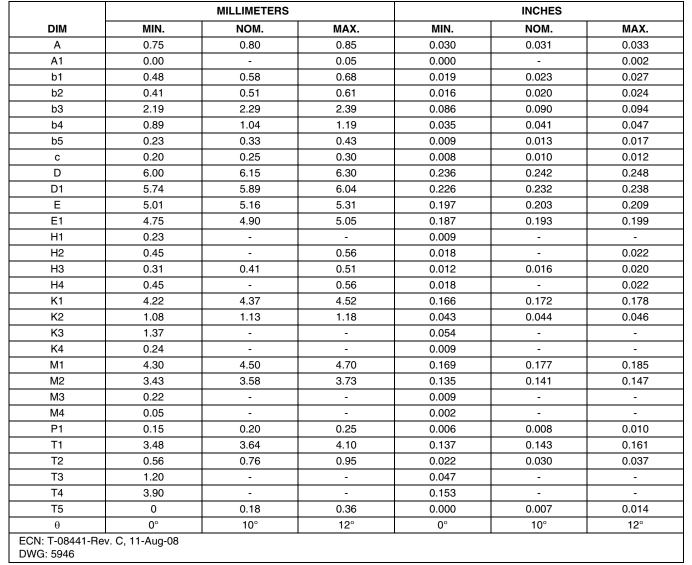

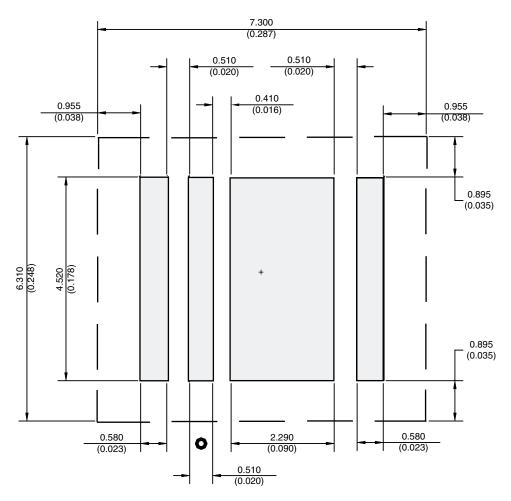
