



 $V_{\text{DS}}$  - Drain-to-Source Voltage (V)




On-Resistance vs. Drain Current and Gate Voltage






On-Resistance vs. Junction Temperature




### Source-Drain Diode Forward Voltage




T<sub>J</sub> - Temperature (°C) **Threshold Voltage**

Single Pulse Power (Junction-to-Ambient)










T<sub>A</sub> - Ambient Temperature (°C) Power, Junction-to-Ambient





Normalized Thermal Transient Impedance, Junction-to-Ambient



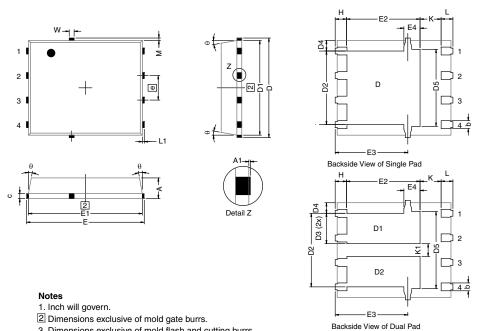
