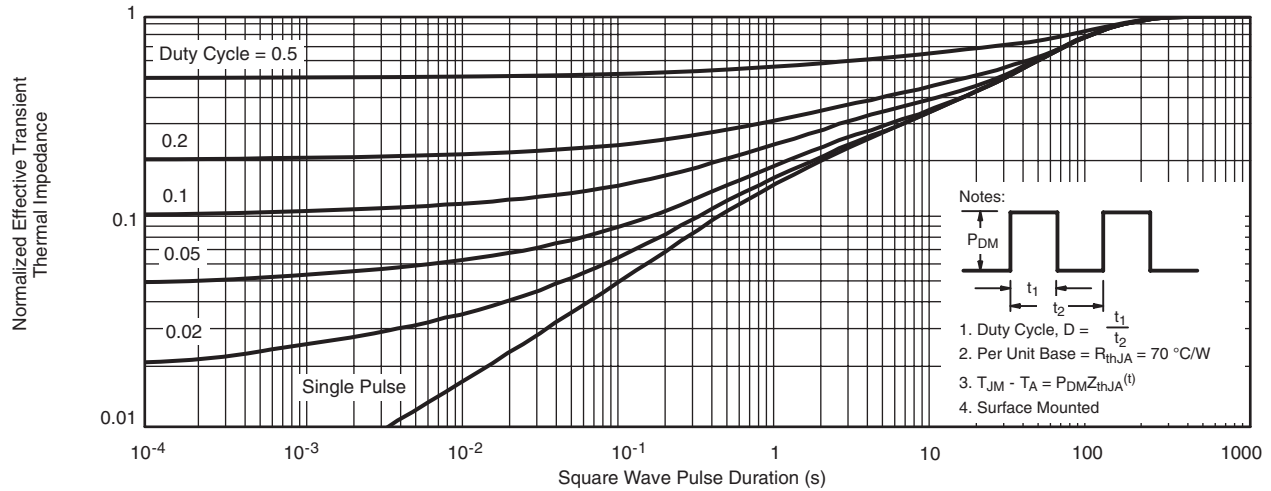
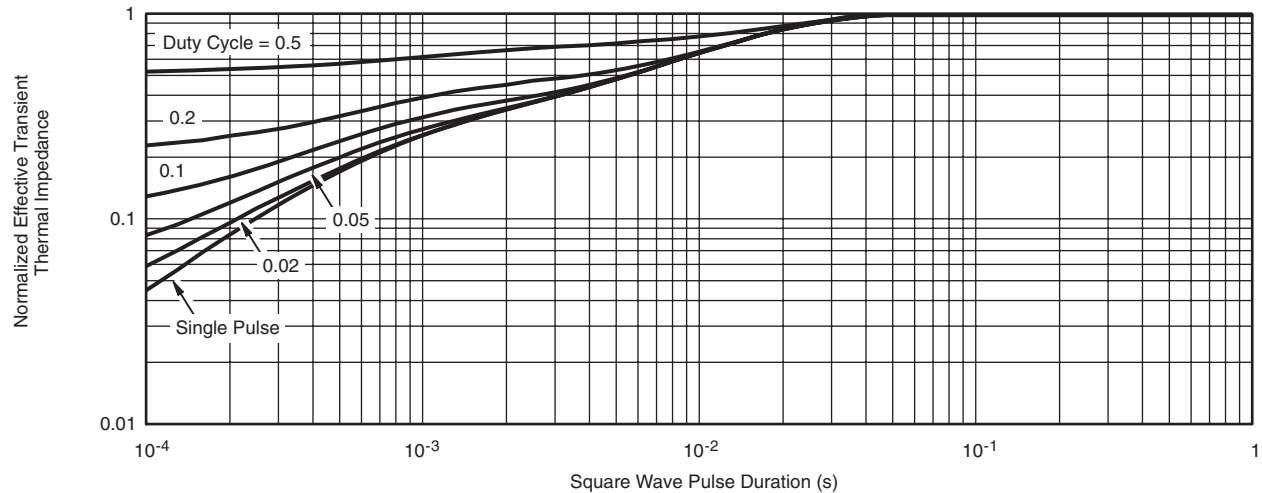


**Power, Junction-to-Case**
