

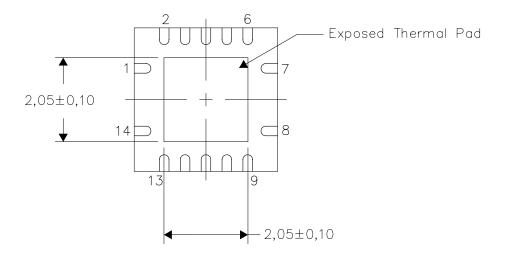

Exposed Thermal Pad Dimensions

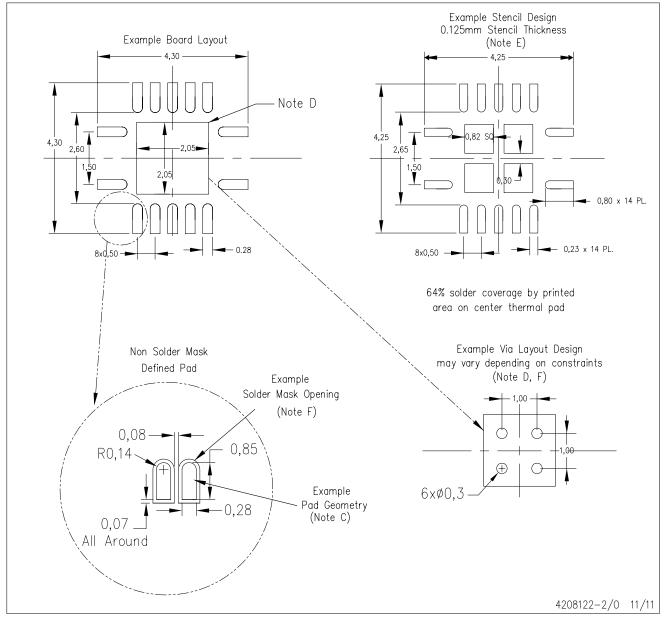
