





SN54ALS804A, SN54AS804B . . . FK PACKAGE (TOP VIEW)



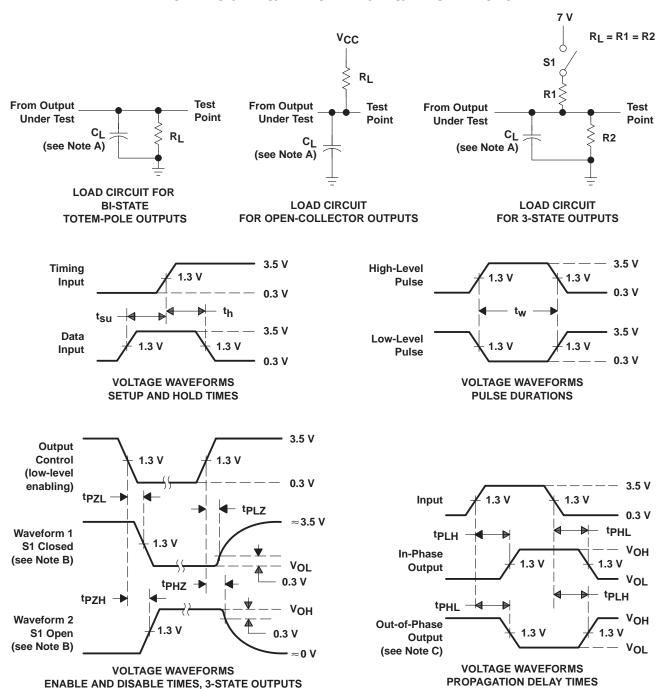
