The SN74AUC04 performs the Boolean function $Y = \overline{A}$.

This device is fully specified for partial-power-down applications using I_{off}. The I_{off} circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.





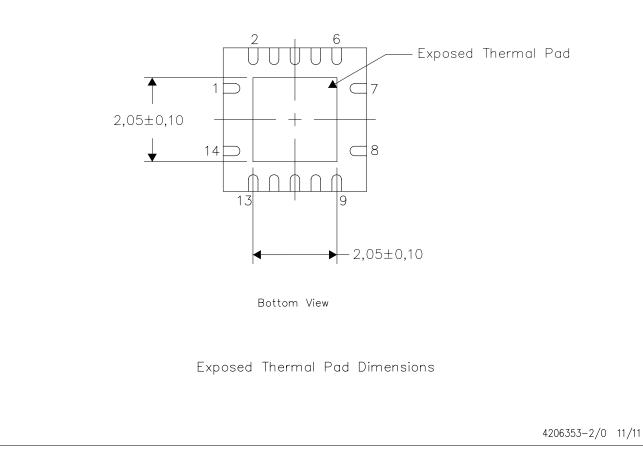

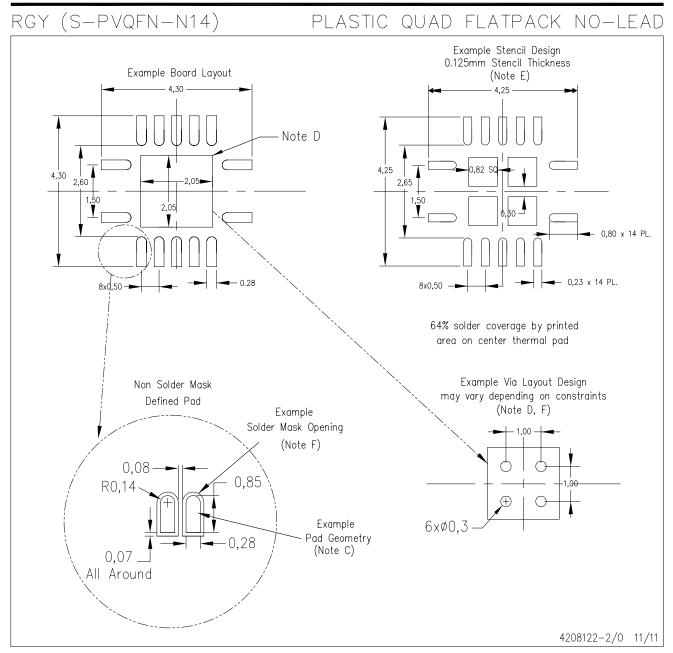
