






Figure 1. AUP - The Lowest-Power Family









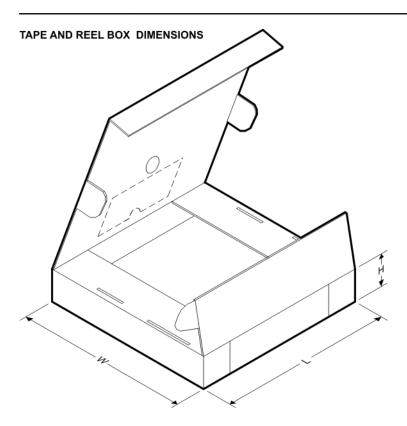

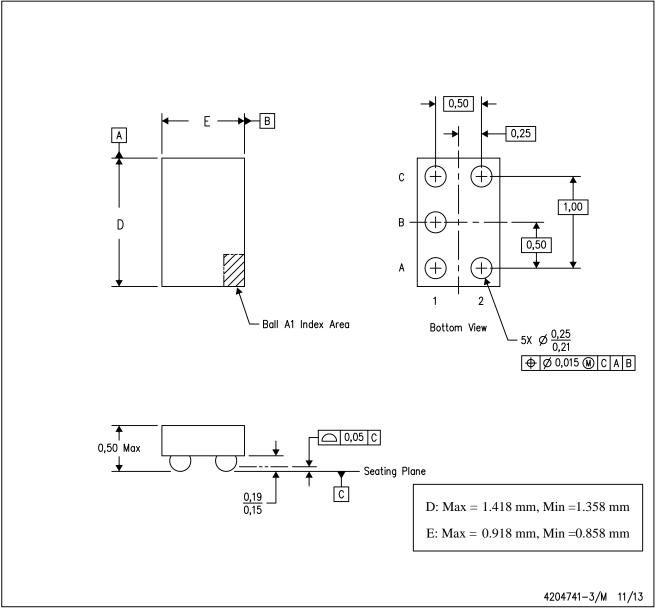
