

DESCRIPTION/ORDERING INFORMATION

The SN74LVC1G38 is designed for 1.65-V to 5.5-V V_{CC} operation.

This <u>device</u> is a <u>single</u> two-input NAND buffer gate with open-drain output. It performs the Boolean function $Y = \overline{A} \cdot \overline{B}$ or $Y = \overline{A} + \overline{B}$ in positive logic.

This device is fully specified for partial-power-down applications using I_{off}. The I_{off} circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.

NanoStar™ and NanoFree™ package technology is a major breakthrough in IC packaging concepts, using the die as the package.







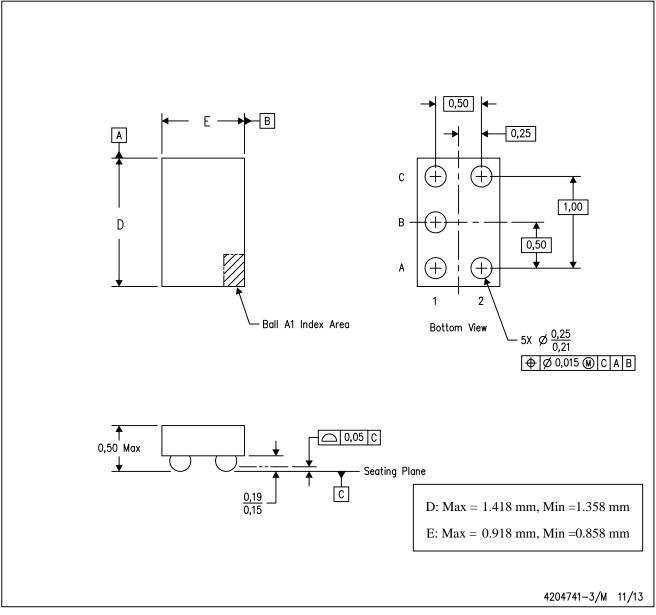
