

The output of the SN74LVC3G06 is open drain and can be connected to other open-drain outputs to implement active-low wired-OR or active-high wired-AND functions. The maximum sink current is 32 mA.

This device is fully specified for partial-power-down applications using I_{off} . The I_{off} circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.



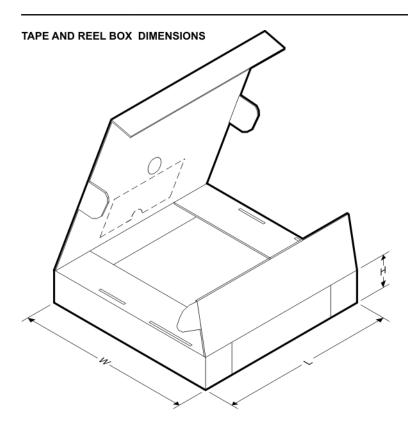
QUADRANT ASSIGNMENTS FOR PIN 1 ORIENTATION IN TAPE

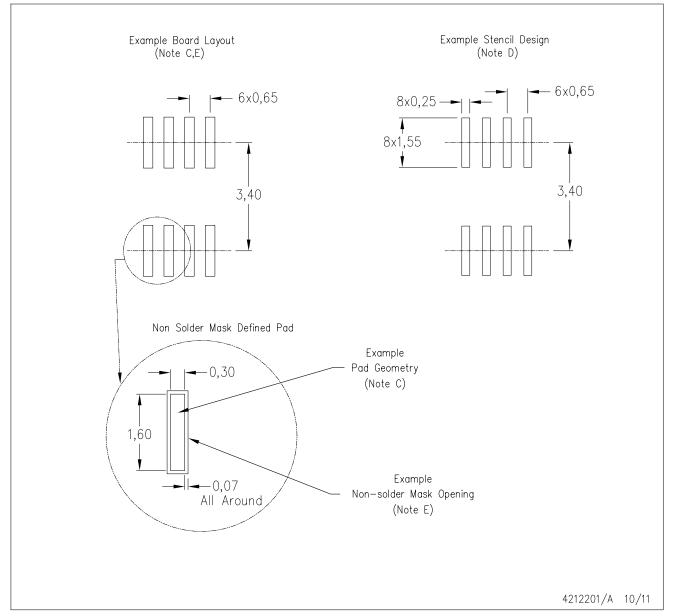

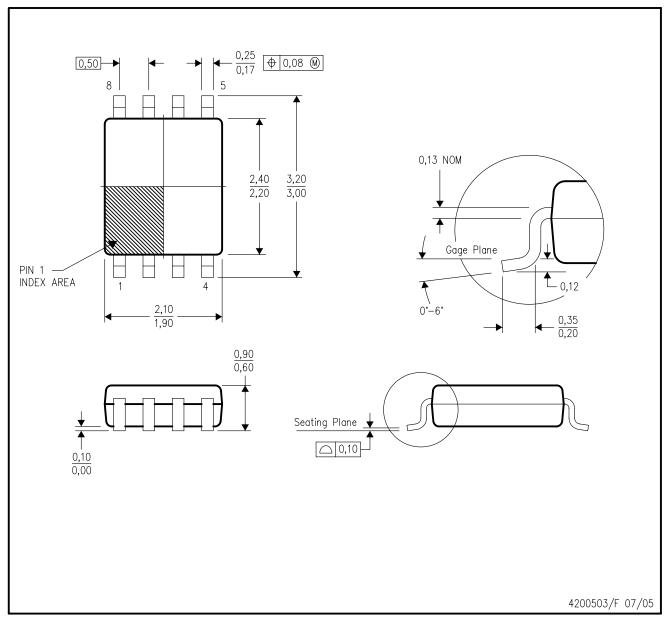

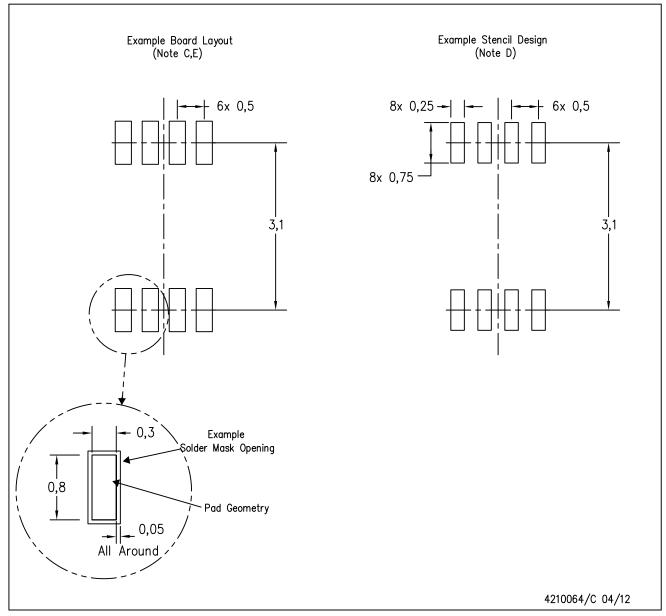
