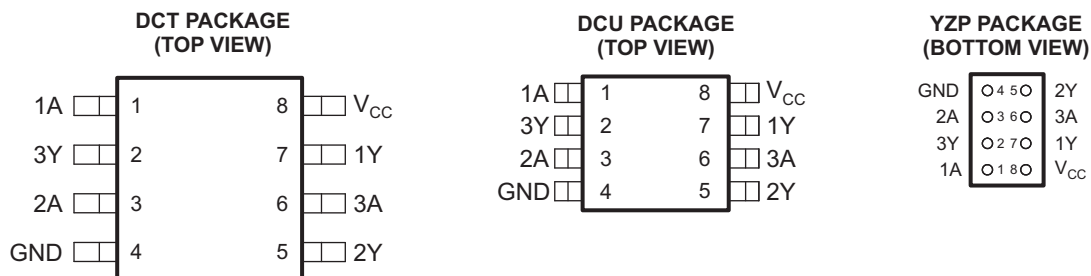

DESCRIPTION

This triple buffer gate is designed for 1.65-V to 5.5-V V_{CC} operation. The SN74LVC3G34 device performs the Boolean function $Y = A$ in positive logic.

NanoFree™ package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using I_{off} . The I_{off} circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.

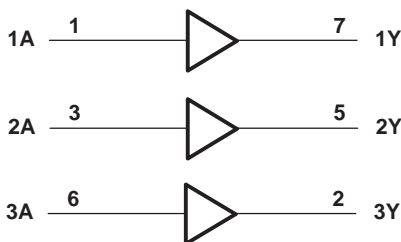

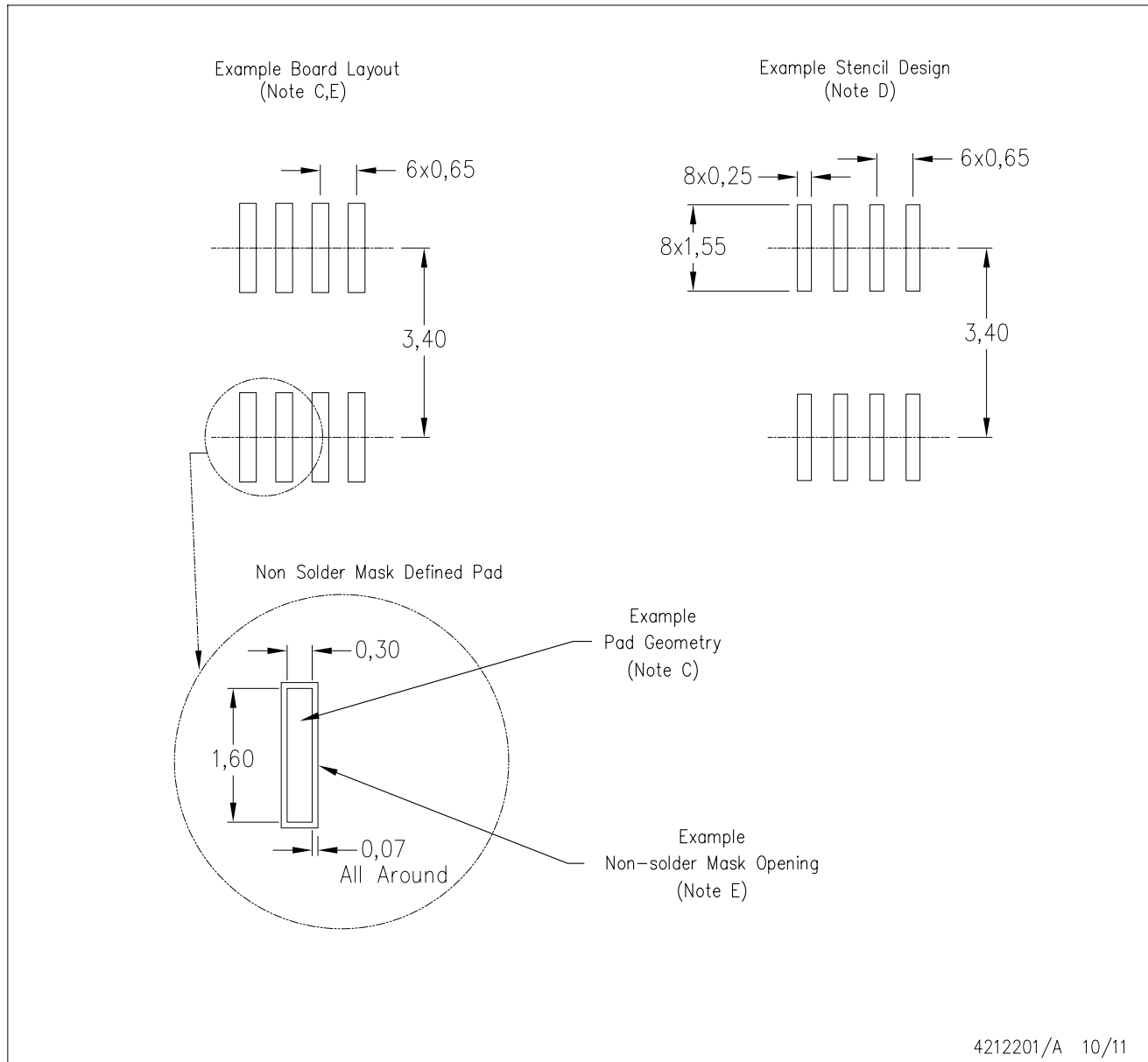

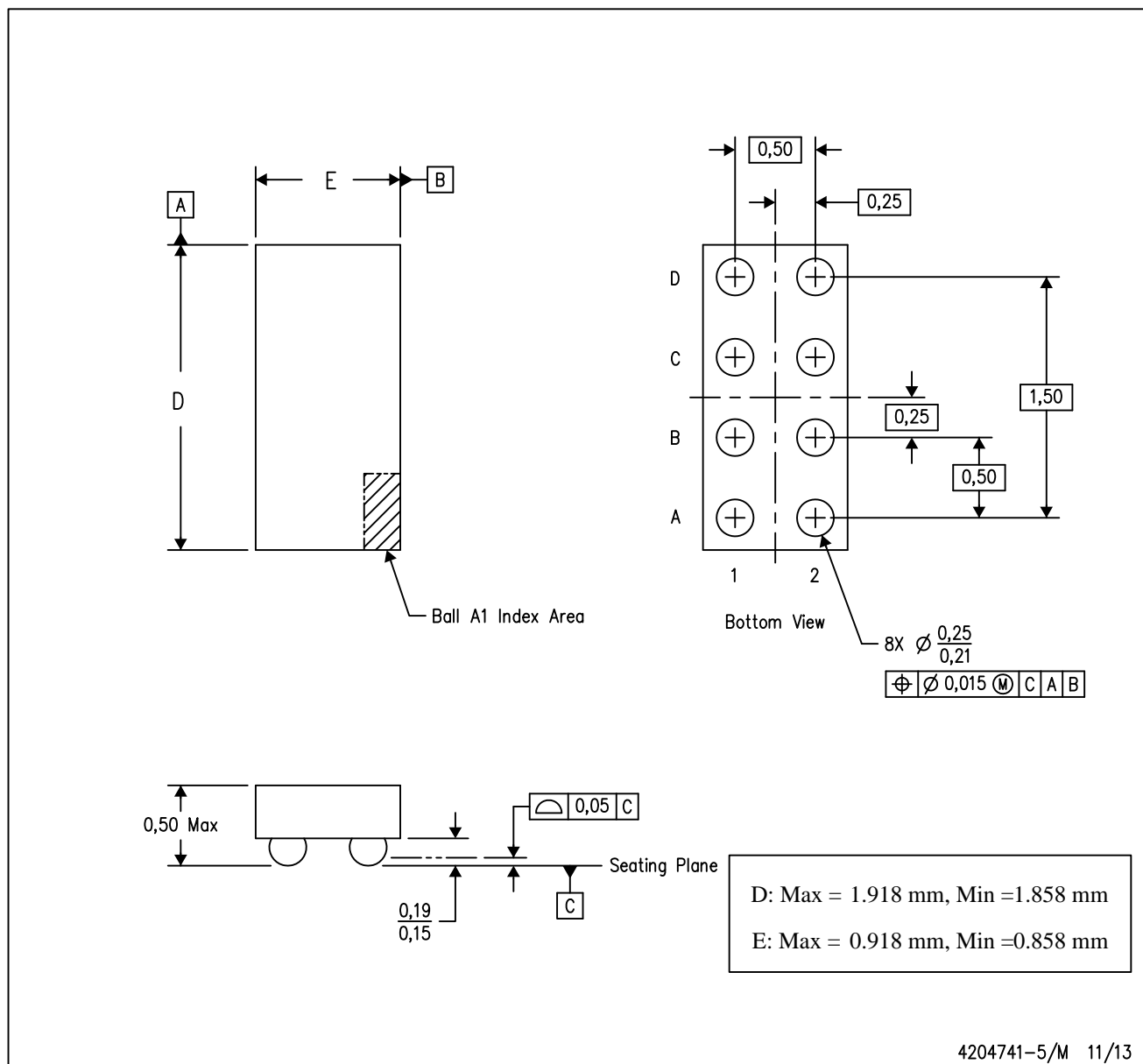
