




Transconductance






Transfer Characteristics




On-Resistance vs. Drain Current







Source Drain Diode Forward Voltage




On-Resistance vs. Gate-to-Source Voltage



Breakdown Voltage vs. Junction Temperature


Normalized On-Resistance vs. Junction Temperature




Threshold Voltage Variance vs. Junction Temperature


