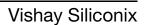
THERMAL RATINGS



Square Wave Pulse Duration (s)

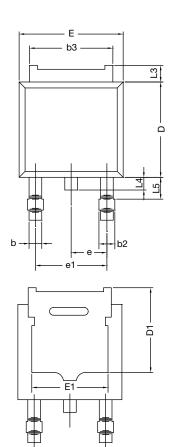
