

### DESCRIPTION

The TPS54318 device is a full featured 6-V, 3-A, synchronous step-down current-mode converter with two integrated MOSFETs.

The TPS54318 enables small designs by integrating the MOSFETs, implementing current mode control to reduce external component count, reducing inductor size by enabling up to 2- MHz switching frequency, and minimizing the IC footprint with a small 3-mm x 3-mm thermally enhanced WQFN package.

The TPS54318 provides accurate regulation for a variety of loads with an accurate  $\pm 1\%$  Voltage Reference (V<sub>ref</sub>) over temperature.


Efficiency is maximized through the integrated  $30\text{-m}\Omega$ MOSFETs and  $350\text{-}\mu\text{A}$  typical supply current. Using the enable pin, shutdown supply current is reduced to 2  $\mu\text{A}$  by entering a shutdown mode.

Undervoltage lockout is internally set at 2.6 V, but can be increased by programming the threshold with a resistor network on the enable pin. The output voltage startup ramp is controlled by the slow-start pin. An open drain power-good signal indicates the output is within 93% to 107% of its nominal voltage.

Frequency foldback and thermal shutdown protects the device during an overcurrent condition.





### FUNCTIONAL BLOCK DIAGRAM






#### **OVERVIEW**

The TPS54318 is a 6-V, 3-A, synchronous step-down (buck) converter with two integrated n-channel MOSFETs. To improve performance during line and load transients the device implements a constant-frequency peakcurrent-mode control which reduces output capacitance and simplifies external frequency compensation design. The wide switching frequency of 200 kHz to 2000 kHz allows for efficiency and size optimization when selecting the output filter components. The switching frequency is adjusted using a resistor to ground on the RT/CLK pin. The device has an internal phase lock loop (PLL) on the RT/CLK pin that is used to synchronize the power switch turn on to a falling edge of an external system clock.

The TPS54318 has a typical default start-up voltage of 2.6 V. The EN pin has an internal pullup current source that is used to adjust the input voltage undervoltage lockout (UVLO) with two external resistors. In addition, the pullup current provides a default condition when the EN pin is floating for the device to operate. The total operating current for the TPS54318 is 350  $\mu$ A when not switching and under no load. When the device is disabled, the supply current is less than 5  $\mu$ A.

The integrated 30-m $\Omega$  MOSFETs allow for high efficiency power supply designs with continuous output currents up to 3 A.

The TPS54318 reduces the external component count by integrating the boot recharge diode. The bias voltage for the integrated high-side MOSFET is supplied by a capacitor on the BOOT to PH pin. The boot capacitor voltage is monitored by an UVLO circuit and turns off the high-side MOSFET when the voltage falls below a preset threshold. This BOOT circuit allows the TPS54318 to operate approaching 100%. The output voltage is stepped down to as low as the 0.8-V reference.

The TPS54318 has a power-good comparator (PWRGD) with 2% hysteresis.

The TPS54318 minimizes excessive output overvoltage transients by taking advantage of the overvoltage powergood comparator. When the regulated output voltage is greater than 109% of the nominal voltage, the overvoltage comparator is activated, and the high-side MOSFET turns off and is masked from turning on until the output voltage is lower than 105%.

The SS (slow-start) pin minimizes inrush currents or provides power-supply sequencing during power up. Usa a small-value capacitor to couple to the pin for slow start. The SS pin is discharged before the output power up to ensure a repeatable restart after an overtemperature fault, UVLO fault, or disabled condition.

The use of a frequency foldback circuit reduces the switching frequency during startup and overcurrent fault conditions to help limit the inductor current.

#### DETAILED DESCRIPTION

#### FIXED-FREQUENCY PWM CONTROL

The TPS54318 uses an adjustable fixed-frequency peak-current-mode control. The output voltage is compared through external resistors on the VSENSE to pin an internal voltage reference by an error amplifier which drives the COMP pin. An internal oscillator initiates the turn on of the high-side power switch. The error amplifier output is compared to the high-side power switch current. When the power switch reaches the COMP voltage, the high-side power switch turns off and the low side power switch turns on.

The COMP pin voltage increases and decreases as the peak switch current increases and decreases. The device implements a current-limit function by clamping the COMP pin voltage to a maximum value, which limits the maximum peak current supplied by the device. The device also implements a minimum COMP voltage clamp for improved transient response. When the COMP voltage is pushed low to the minimum clamp, such as during a load release event, turn-on of the high-side power switch is inhibited.

#### SLOPE COMPENSATION AND OUTPUT CURRENT

The TPS54318 adds a compensating ramp to the switch current signal. This slope compensation prevents subharmonic oscillations as duty cycle increases. The available peak inductor current remains constant over the full duty-cycle range.

#### BOOTSTRAP VOLTAGE (BOOT) AND LOW DROPOUT OPERATION

The TPS54318 has an integrated boot regulator and requires a small ceramic capacitor between the BOOT and PH pin to provide the gate-drive voltage for the high-side MOSFET. The value of the ceramic capacitor should be 0.1  $\mu$ F. A ceramic capacitor with an X7R or X5R grade dielectric with a voltage rating of 10 V or higher is recommended because of the stable characteristics over temperature and voltage.

To improve drop out, the TPS54318 is designed to operate at 100% duty cycle as long as the BOOT to PH pin voltage is greater than 2.5 V. The high-side MOSFET turns off using an UVLO circuit, allowing for the low-side MOSFET to conduct when the voltage from BOOT to PH drops below 2.5 V. Because the supply current sourced from the BOOT pin is low, the high-side MOSFET remains on for more switching cycles than are required to refresh the capacitor, thus the effective duty cycle of the switching regulator is high.

#### ERROR AMPLIFIER

The TPS54318 has a transconductance amplifier. The error amplifier compares the VSENSE voltage to the lower of the SS pin voltage or the internal 0.8-V voltage reference. The transconductance of the error amplifier is 225  $\mu$ A/V during normal operation. When the voltage of VSENSE pin is below 0.8 V and the device regulates using the SS voltage, the gm is 70  $\mu$ A/V. The frequency-compensation components are placed between the COMP pin and ground.

#### **VOLTAGE REFERENCE**

The voltage reference system produces a precise  $\pm 1\%$  voltage reference overtemperature by scaling the output of a temperature stable bandgap circuit. The bandgap and scaling circuits produce 0.8 V at the non-inverting input of the error amplifier.

#### ADJUSTING THE OUTPUT VOLTAGE

The output voltage is set with a resistor divider from the output node to the VSENSE pin. TI recommends to use divider resistors with 1% tolerance or better. Start with a 100 k $\Omega$  for the R1 resistor and use Equation 1 to calculate R2. To improve efficiency at light loads consider using larger value resistors. If the values are too high the regulator is more susceptible to noise, and voltage errors from the VSENSE input current are noticeable.




Figure 23. Voltage Divider Circuit

#### ENABLE AND ADJUSTING UNDERVOLTAGE LOCKOUT




Figure 24. Adjustable Undervoltage Lockout

The TPS54318 is disabled when the VIN pin voltage falls below 2.6 V. If an application requires a higher undervoltage lockout (UVLO), use the EN pin as shown in Figure 24 to adjust the input voltage UVLO by using two external resistors. TI recommends to use the enable resistors to set the UVLO falling threshold ( $V_{STOP}$ ) above 2.7 V. The rising threshold ( $V_{START}$ ) should be set to provide enough hysteresis to allow for any input supply variations. The EN pin has an internal pull-up current source that provides the default condition of the TPS54318 operating when the EN pin floats. Once the EN pin voltage exceeds 1.25 V, an additional 2.55  $\mu$ A of hysteresis is added. When the EN pin is pulled below 1.18 V, the 2.55  $\mu$ A is removed. This additional current facilitates input voltage hysteresis.

#### **SLOW-START PIN**

The TPS54318 regulates to the lower of the SS pin and the internal reference voltage. A capacitor on the SS pin to ground implements a slow-start time. The TPS54318 has an internal pullup current source of 1.8  $\mu$ A which charges the external slow-start capacitor. Equation 4 calculates the required slow-start capacitor value where T<sub>SS</sub> is the desired slow-start time in ms, I<sub>SS</sub> is the internal slow-start charging current of 1.8  $\mu$ A, and V<sub>ref</sub> is the internal voltage reference of 0.8 V. TI recommends to keep the soft-start time in the range of 1 ms to 10 ms.

If during normal operation, the VIN goes below the UVLO, EN pin pulled below 1.2 V, or a thermal shutdown event occurs, the TPS54318 stops switching and the SS is discharged to 0 V before reinitiating a powering-up sequence.

#### SEQUENCING




Figure 25. Sequential Startup Sequence

Many of the common power-supply sequencing methods are implemented using the SS, EN, and PWRGD pins. The sequential method is implemented using an open drain or collector output of a power-on reset pin of another device. Figure 25 shows the sequential method. The power good is coupled to the EN pin on the TPS54318 which enables the second power supply once the primary supply reaches regulation.

Ratiometric startup is accomplished by connecting the SS pins together. The regulator outputs ramp up and reach regulation at the same time. When calculating the slow-start time the pullup current source must be doubled in Equation 4. The ratiometric method is illustrated in Figure 27.





Figure 26. Sequential Start-Up Using EN and PWRGD




Figure 28. Ratiometric Start-Up Using Coupled SS Pins

#### CONSTANT SWITCHING FREQUENCY and TIMING RESISTOR (RT/CLK Pin)

The switching frequency of the TPS54318 is adjustable over a wide range from 200 kHz to 2000 kHz by placing a maximum of 1000 k $\Omega$  and minimum of 85 k $\Omega$ , respectively, on the RT/CLK pin. An internal amplifier holds this pin at a fixed voltage when using an external resistor to ground to set the switching frequency. The RT/CLK is typically 0.5 V. To determine the timing resistance for a given switching frequency, use the curve in Figure 5 and Figure 6, or Equation 5.

To reduce the solution size one would typically set the switching frequency as high as possible, but consider the tradeoffs of efficiency, maximum input voltage, and minimum controllable on-time.

The minimum controllable on-time is typically 60 ns at full-current load and 110 ns at no load, and limits the maximum operating input voltage or output voltage.

#### **OVERCURRENT PROTECTION**

The TPS54318 implements a cycle-by-cycle current limit. During each switching cycle the high-side switch current is compared to the voltage on the COMP pin. When the instantaneous switch current intersects the COMP voltage, the high-side switch is turned off. During overcurrent conditions that pull the output voltage low, the error amplifier responds by driving the COMP pin high, increasing the switch current. The error amplifier output is clamped internally. This clamp functions as a switch current limit.

#### FREQUENCY SHIFT

To operate at high switching frequencies and provide protection during overcurrent conditions, the TPS54318 implements a frequency shift. If frequency shift is not implemented, during an overcurrent condition the low-side MOSFET may not turn off long enough to reduce the current in the inductor, causing a current runaway. With frequency shift, during an overcurrent condition the switching frequency is reduced from 100%, then 75%, then 50%, then 25% as the voltage decreases from 0.8 to 0 V on VSENSE pin to allow the low-side MOSFET to be off long enough to decrease the current in the inductor. During start-up, the switching frequency increases as the voltage on VSENSE increases from 0 to 0.8 V. See Figure 7 for details.




#### **REVERSE OVERCURRENT PROTECTION**

The TPS54318 implements low-side current protection by detecting the voltage across the low-side MOSFET. When the converter sinks current through its low-side FET, the control circuit turns off the low-side MOSFET if the reverse current is more than 1.3 A. By implementing this additional protection scheme, the converter is able to protect itself from excessive current during power cycling and start-up into pre-biased outputs.

#### SYNCHRONIZE USING THE RT/CLK PIN




Figure 29. Synchronizing to a System Clock

The RT/CLK pin is used to synchronize the converter to an external system clock. See Figure 29. To implement the synchronization feature in a system, connect a square wave to the RT/CLK pin with an on-time of at least 75 ns. If the pin is pulled above the PLL upper threshold, a mode change occurs and the pin becomes a synchronization input. The internal amplifier is disabled and the pin is a high impedance clock input to the internal PLL. If clocking edges stop, the internal amplifier is re-enabled and the mode returns to the frequency set by the resistor. The square wave amplitude at this pin must transition lower than 0.6 V and higher than 1.6 V typically. The recommended synchronization frequency range is 300 kHz to 2000 kHz. The rising edge of the PH is synchronized to the falling edge of RT/CLK pin. If the external system clock is to be removed, TI recommends that it be removed on the falling edge of the clock signal.

#### POWER GOOD (PWRGD PIN)

The PWRGD pin output is an open-drain MOSFET. The output is pulled low when the VSENSE voltage enters the fault condition by falling below 91% or rising above 107% of the nominal internal reference voltage. There is a 2% hysteresis on the threshold voltage, so when the VSENSE voltage rises to the good condition above 93% or falls below 105% of the internal voltage reference the PWRGD output MOSFET is turned off. TI recommends to use a pullup resistor between the values of 1 k $\Omega$  and 100 k $\Omega$  to a voltage source that is 6 V or less. The PWRGD is in a valid state once the VIN input voltage is greater than 1.2 V.

#### **OVERVOLTAGE-TRANSIENT PROTECTION**

The TPS54318 incorporates an overvoltage-transient-protection (OVTP) circuit to minimize voltage overshoot when recovering from output fault conditions or strong unload transients. The OVTP feature minimizes the output overshoot by implementing a circuit to compare the VSENSE pin voltage to the OVTP threshold which is 109% of the internal voltage reference. If the VSENSE pin voltage is greater than the OVTP threshold, the high-side MOSFET is disabled preventing current from flowing to the output and minimizing output overshoot. When the VSENSE voltage drops lower than the OVTP threshold the high-side MOSFET is allowed to turn on the next clock cycle.

#### THERMAL SHUTDOWN

The device implements an internal thermal shutdown to protect itself if the junction temperature exceeds 175°C. The thermal shutdown forces the device to stop switching when the junction temperature exceeds the thermal trip threshold. Once the die temperature decreases below 160°C, the device reinitiates the power-up sequence by discharging the SS pin to 0 V. The thermal shutdown hysteresis is 15°C.

#### SMALL-SIGNAL MODEL FOR LOOP RESPONSE





Figure 31. Small-Signal Model for Loop Response

Figure 31 shows an equivalent model for the TPS54318 control loop which can be modeled in a circuit simulation program to check frequency response and dynamic load response. The error amplifier is a transconductance amplifier with a gm of 225  $\mu$ A/V. The error amplifier is modeled using an ideal voltage controlled current source. The resistor Ro and capacitor Co model the open-loop gain and frequency response of the amplifier. The 1-mV AC voltage source between the nodes a and b effectively breaks the control loop for the frequency response measurements. Plotting a/c shows the small signal response of the frequency compensation. Plotting a/b shows the small signal response is checked by replacing the R<sub>L</sub> with a current source with the appropriate load step amplitude and step rate in a time domain analysis.

#### SIMPLE SMALL-SIGNAL MODEL FOR PEAK-CURRENT-MODE CONTROL

Figure 31 is a simple small-signal model that is used to understand how to design the frequency compensation. The TPS54318 power stage can be approximated to a voltage controlled current source (duty-cycle modulator) supplying current to the output capacitor and load resistor. The control to output transfer function is shown in Equation 7 and consists of a DC gain, one dominant pole, and one ESR zero. The quotient of the change in switch current and the change in COMP pin voltage (node c in Figure 31) is the power-stage transconductance. The gm for the TPS54318 is 13 A/V. The low frequency gain of the power-stage frequency response is the product of the transconductance and the load resistance as shown in Equation 8. As the load current increases and decreases, the low frequency gain decreases and increases, respectively. This variation with load may seem problematic at first glance, but the dominant pole moves with load current (see Equation 9). The combined effect is highlighted by the dashed line in the right half of Figure 32. As the load current decreases, the gain increases and the pole frequency lowers, keeping the 0-dB crossover frequency the same for the varying load conditions which makes it easier to design the frequency compensation.

#### SMALL SIGNAL MODEL FOR FREQUENCY COMPENSATION




Figure 33. Types of Frequency Compensation

The TPS54318 uses a transconductance amplifier for the error amplifier and readily supports two of the commonly used frequency compensation circuits. The compensation circuits are shown in Figure 33. The Type 2 circuits are most likely implemented in high bandwidth power-supply designs using low ESR output capacitors. In Type 2A, one additional high frequency pole is added to attenuate high frequency noise.

The design guidelines for TPS54318 loop compensation are as follows:

 The modulator pole, fpmod, and the ESR zero, fz1 must be calculated using Equation 11 and Equation 12. Derating the output capacitor (C<sub>OUT</sub>) is required if the output voltage is a high percentage of the capacitor rating. Use the capacitor manufacturer information to derate the capacitor value. Use Equation 13 and Equation 14 to estimate a starting point for the crossover frequency, fc. #### DESIGN GUIDE – STEP-BY-STEP DESIGN PROCEDURE

This example details the design of a high frequency switching regulator design using ceramic output capacitors. This design is available as the HPA512 evaluation module (EVM). A few parameters must be known in order to start the design process. These parameters are typically determined on the system level. For this example, we start with the following known parameters:

Output Voltage	1.8 V
Transient Response 1- to 2-A load step	$\Delta V_{OUT} = 3\%$
Maximum Output Current	3 A
Input Voltage	3.3 V nominal 3 V to 6 V
Output Voltage Ripple	< 30 mV <sub>PP</sub>
Start Input Voltage (rising VIN)	3.1 V
Stop Input Voltage (falling VIN)	2.8 V
Switching Frequency (fsw)	1000 kHz

#### SELECTING THE SWITCHING FREQUENCY

The first step is to decide on a switching frequency for the regulator. Typically, you want to choose the highest switching frequency possible because this produces the smallest solution size. The high switching frequency allows for lower valued inductors and smaller output capacitors compared to a power supply that switches at a lower frequency. However, the highest switching frequency causes extra switching losses, which hurt the performance of the converter. The converter is capable of running from 200 kHz to 2 MHz. Unless a small solution size is an ultimate goal, a moderate switching frequency of 1 MHz is selected to achieve both a small solution size and a high efficiency operation. Using Equation 5, R4 is calculated to be 180 k $\Omega$ . A standard 1% 182 k $\Omega$  value was chosen in the design.




Figure 34. High-Frequency 1.8-V Output Power-Supply Design With Adjusted UVLO

#### OUTPUT INDUCTOR SELECTION

The inductor selected works for the entire TPS54318 input voltage range. To calculate the value of the output inductor, use Equation 18.  $K_{IND}$  is a coefficient that represents the amount of inductor ripple current relative to the maximum output current. The inductor ripple current is filtered by the output capacitor. Therefore, choosing high inductor ripple currents impacts the selection of the output capacitor because the output capacitor must have a ripple current rating equal to or greater than the inductor ripple current. In general, the inductor ripple value is at the discretion of the designer; however,  $K_{IND}$  is normally from 0.1 to 0.3 for the majority of applications.

For this design example, use  $K_{IND} = 0.3$  and the inductor value is calculated to be 1.4 µH. For this design, a nearest standard value was chosen: 1.5 µH. For the output filter inductor, it is important that the RMS current and saturation current ratings not be exceeded. The RMS and peak inductor current is found from Equation 20 and Equation 21.

For this design, the RMS inductor current is 3.01 A and the peak inductor current is 3.42 A. The chosen inductor is a Coilcraft XPL7030-152ML\_. The inductor has an RMS current rating of 12.3 A and a saturation current rating of 20.2 A. The current ratings for this exceed the requirement, but the inductor was chosen for small physical size and low series resistance for high efficiency.

The current flowing through the inductor is the inductor ripple current plus the output current. During power-up, faults or transient load conditions, the inductor current increases above the calculated peak inductor current level calculated above. In transient conditions, the inductor current can increase up to the switch current limit of the device. For this reason, the most conservative approach is to specify an inductor with a saturation current rating equal to or greater than the switch current limit rather than the peak inductor current.

#### OUTPUT CAPACITOR

There are three primary considerations for selecting the value of the output capacitor. The output capacitor determines the modulator pole, the output voltage ripple, and how the regulator responds to a large change in load current. The output capacitance must be selected based on the more stringent of these three criteria.

The desired response to a large change in the load current is the first criteria. The output capacitor must supply the load with current when the regulator cannot. This situation occurs if there are desired hold-up times for the regulator where the output capacitor must hold the output voltage above a certain level for a specified amount of time after the input power is removed. The regulator is temporarily not able to supply sufficient output current if there is a large, fast increase in the current needs of the load such as transitioning from no load to a full load. The regulator usually requires two or more clock cycles for the control loop to see the change in load current and output voltage and adjust the duty cycle to react to the change. The output capacitor must be sized to supply the extra current to the load until the control loop responds to the load change. The output capacitance must be large enough to supply the difference in current for 2 clock cycles while only allowing a tolerable amount of droop in the output voltage. Equation 22 shows the minimum output capacitance necessary to accomplish this.

For this example, the transient load response is specified as a 3% change in V<sub>OUT</sub> for a load step from 1.25 A to 2.75 A For this example,  $\Delta I_{OUT} = 2.75 - 1.25 = 1.5$  A and  $\Delta V_{OUT} = 0.03 \times 1.8 = 0.054$  V. Using these numbers gives a minimum capacitance of 56 µF. This value does not take the ESR of the output capacitor into account in the output voltage change. For ceramic capacitors, the ESR is usually small enough to ignore in this calculation.

Equation 23 calculates the minimum output capacitance needed to meet the output voltage ripple specification. Where *f* sw is the switching frequency,  $V_{ripple}$  is the maximum allowable output voltage ripple, and  $I_{ripple}$  is the inductor ripple current. In this case, the maximum output voltage ripple is 30 mV. Under this requirement, Equation 23 yields 3.2  $\mu$ F.

Equation 24 calculates the maximum ESR an output capacitor can have to meet the output voltage ripple specification. Equation 24 indicates the ESR should be less than 39 m $\Omega$ . In this case, the ESR of the ceramic capacitor is much less than 39 m $\Omega$ .

Additional capacitance de-ratings for aging, temperature and DC bias should be factored in which increases this minimum value. For this example, three 22  $\mu$ F 10 V X5R ceramic capacitors with 3 m $\Omega$  of ESR are used.

Capacitors generally have limits to the amount of ripple current they can handle without failing or producing excess heat. An output capacitor that can support the inductor ripple current must be specified. Some capacitor data sheets specify the Root-Mean-Square (RMS) value of the maximum ripple current. Equation 25 calculates the RMS ripple current required by the output capacitor for support. For this application, Equation 25 yields 222 mA.

#### **INPUT CAPACITOR**

The TPS54318 requires a high quality ceramic, type X5R or X7R, input decoupling capacitor of at least 4.7 µF of effective capacitance and, in some applications, a bulk capacitance. The effective capacitance includes any DC-bias effects. The voltage rating of the input capacitor must be greater than the maximum input voltage. The capacitor must also have a ripple current rating greater than the maximum input current ripple of the TPS54318. The input ripple current is calculated using Equation 26.

The value of a ceramic capacitor varies significantly over temperature and the amount of DC bias applied to the capacitor. The capacitance variations due to temperature is minimized by selecting a dielectric material that is stable over temperature. X5R and X7R ceramic dielectrics are usually selected for power regulator capacitors because they have a high capacitance-to-volume ratio and are fairly stable over temperature. The output capacitor must also be selected with the DC bias taken into account. The capacitance value of a capacitor decreases as the DC bias across a capacitor increases.

For this example design, a ceramic capacitor with at least a 10-V voltage rating is required to support the maximum input voltage. For this example, one 10- $\mu$ F and one 0.1- $\mu$ F 10-V capacitors in parallel have been selected. The input capacitance value determines the input ripple voltage of the regulator. The input voltage ripple is calculated using Equation 27. Using the design example values, I<sub>OUT</sub>max = 3 A, C<sub>IN</sub> = 10  $\mu$ F, *f*sw = 1 MHz, yields an input voltage ripple of 51 mV and a RMS input ripple current of 1.47 A.

COMP VOLTAGE LEVEL

The TPS54318 implements a minimum COMP voltage clamp for improved load transient response. The COMP voltage tracks the peak inductor current, increasing as the peak inductor current increases, and decreasing as the peak inductor current decreases. During a severe load dump event, for instance, the COMP voltage decreases suddenly, falls below the minimum clamp value, then settles to a lower DC value as the control loop compensates for the transient event. During the time when COMP reaches the minimum clamp voltage, turn-on of the high-side power switch is inhibited, keeping the low-side power switch on to discharge the output voltage overshoot more quickly.

Proper application circuit design should ensure that the minimum load steady-state COMP voltage is above the +3 sigma minimum clamp to avoid unwanted inhibition of the high side power switch. For a given design, the steady-state DC level of COMP is measured at the minimum designed load, and the maximum designed input voltage, then compared to the minimum COMP clamp voltage shown in Figure 22. These conditions represent the minimum COMP voltage conditions for a given design. Generally, the COMP voltage and minimum clamp voltage move about by the same amount with temperature. Increasing the minimum load COMP voltage is accomplished by decreasing the the output inductor value or the switching frequency used in a given design.

#### SLOW START CAPACITOR

The slow-start capacitor determines the minimum amount of time for the output voltage to reach the nominal programmed value during power up. The slow-start function is useful if a load requires a controlled voltage slew rate. This function is also used if the output capacitance is large and would require large amounts of current to quickly charge the capacitor to the output voltage level. The large currents necessary to charge the capacitor cause the TPS54318 to reach the current limit, or excessive current draw from the input power supply can cause the input voltage rail to sag. Limiting the output voltage slew rate solves both of these problems.

The slow-start capacitor value is calculated using Equation 28. For the example circuit, the slow-start time is not too critical because the output capacitor value is 44  $\mu$ F which does not require much current to charge to 1.8 V. The example circuit has the slow-start time set to an arbitrary value of 4 ms which requires a 10 nF capacitor. In TPS54318, Iss is 2  $\mu$ A and V<sub>ref</sub> is 0.8 V. TI Recommends keeping the soft-start time in the range of 1 ms to 10 ms.

#### **BOOTSTRAP CAPACITOR SELECTION**

A 0.1-µF ceramic capacitor must be connected between the BOOT to PH pin for proper operation. TI recommends to use a ceramic capacitor with X5R or better grade dielectric. The capacitor should have a 10-V or higher voltage rating.

#### UNDERVOLTAGE LOCKOUT SET POINT

The Undervoltage Lockout (UVLO) is adjusted using an external voltage divider on the EN pin of the TPS54318. The UVLO has two thresholds, one for power-up when the input voltage is rising and one for power-down or brown-outs when the input voltage is falling. For the example design, the supply should turn on and start switching once the input voltage increases above 3.1 V ( $V_{START}$ ). After the regulator starts switching, it should continue to do so until the input voltage falls below 2.8 V ( $V_{STOP}$ ).

The programmable UVLO and enable voltages are set using a resistor divider between Vin and ground to the EN pin. Equation 29 and Equation 30 are used to calculate the resistance values necessary. From Equation 29 and Equation 30, a 48.7 k $\Omega$  between Vin and EN and a 32.4 k $\Omega$  between EN and ground are required to produce the 3.1- and 2.8-V start and stop voltages.

#### **OUTPUT VOLTAGE AND FEEDBACK RESISTORS SELECTION**

For the example design, 100 k $\Omega$  was selected for R6. Using Equation 31, R7 is calculated as 80 k $\Omega$ . The nearest standard 1% resistor is 80.5 k $\Omega$ .

Due to the internal design of the TPS54318, there is a minimum output voltage limit for any given input voltage. The output voltage can never be lower than the internal voltage reference of 0.8 V. Above 0.8 V, the output voltage may be limited by the minimum controllable on time. The minimum output voltage in this case is given by Equation 32

#### COMPENSATION

There are several industry techniques used to compensate DC-DC regulators. The method presented here is easy to calculate and yields high phase margins. For most conditions, the regulator has a phase margin between 60 and 90 degrees. The method presented here ignores the effects of the slope compensation that is internal to the TPS54318. Because the slope compensation is ignored, the actual crossover frequency is usually lower than the crossover frequency used in the calculations. Use SwitcherPro software for a more accurate design.

To get started, the modulator pole, fpmod, and the ESR zero, fz1 must be calculated using Equation 34 and Equation 12. For  $C_{OUT}$ , derating the capacitor is not needed as the 1.8 V output is a small percentage of the 10 V capacitor rating. If the output is a high percentage of the capacitor rating, use the capacitor manufacturer information to derate the capacitor value. Use Equation 36 and Equation 37 to estimate a starting point for the crossover frequency, fc. For the example design, fpmod is 4.02 kHz and fzmod is 804 kHz. Equation 36 is the geometric mean of the modulator pole and the ESR zero and Equation 37 is the mean of modulator pole and the switching frequency. Equation 36 yields 5.6 kHz and Equation 37 gives 44.8 kHz. Use the lower value of Equation 36 or Equation 37 as the maximum crossover frequency. For this example, fc is 45 kHz. Next, the compensation components are calculated. A resistor in series with a capacitor is used to create a compensating zero. A capacitor in parallel to these two components forms the compensating pole (if needed).


2. Place compensation zero at the pole formed by the load resistor and the output capacitor. The compensation network's capacitor is calculated from Equation 39.

$$C3 = \frac{R_{OUT} \times C_{OUT}}{R3}$$

3. An additional pole can be added to attenuate high frequency noise. In this application, adding the additional pole is not necessary.

From the procedures above, the compensation network includes a 9.53-kΩ resistor and a 3900-pF capacitor.






Figure 51. Junction Temperature vs IC Power Dissipation




Figure 52. Maximum Ambient Temperature vs IC power Dissipation


### LAYOUT

Layout is a critical portion of good power supply design. There are several signal paths that conduct fast changing currents or voltages that can interact with stray inductance or parasitic capacitance to generate noise or degrade the power supplies performance. Care should be taken to minimize the loop area formed by the bypass capacitor connections and the VIN pins. See Figure 53 for a PCB layout example. The GND pins and AGND pin should be tied directly to the power pad under the IC. The power pad should be connected to any internal PCB ground planes using multiple vias directly under the IC. Additional vias can be used to connect the top side ground area to the internal planes near the input and output capacitors. For operation at full rated load, the top side ground area along with any additional internal ground planes must provide adequate heat dissipating area.

Locate the input bypass capacitor as close to the IC as possible. The PH pin should be routed to the output inductor. Because the PH connection is the switching node, the output inductor should be located close to the PH pins, and the area of the PCB conductor minimized to prevent excessive capacitive coupling. The boot capacitor must also be located close to the device. The sensitive analog ground connections for the feedback voltage divider, compensation components, slow-start capacitor and frequency set resistor should be connected



to a separate analog ground trace as shown. The RT/CLK pin is particularly sensitive to noise so the RT resistor should be located as close as possible to the IC and routed with minimal lengths of trace. The additional external components can be placed approximately as shown. It is possible to obtain acceptable performance with alternate PCB layouts; however, this layout has been shown to produce good results and is meant as a guideline.




