





Fig. 1 - Forward Current Derating Curve




Fig. 2 - Forward Power Loss Characteristics




Fig. 5 - Typical Junction Capacitance




Fig. 3 - Typical Instantaneous Forward Characteristics






Fig. 6 - Typical Transient Thermal Impedance




PACKAGE OUTLINE DIMENSIONS in inches (millimeters) TO-220AB
